ADVERTISEMENT FOR BID

The Finance Department of the City of Parkersburg, at One Government Square, Parkersburg WV, will receive sealed bids until **10:00 A.M., Tuesday January 26, 2010**. All sealed bids received by that time will be opened and publicly read aloud for the **#2009-14 Municipal Building Tankless Water Heaters Project**.

The City of Parkersburg reserves the right to reject any or all bids and to waive any informality therein.

Bidders on this work will be required to comply with the President's Executive Order No. 11246, "HUD Section 109" and Non-Segregated Facilities which prohibit discrimination in employment regarding race, creed, color, sex or national origin.

Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, The Anti-Kickback Act, and the Contract WorkHouse Standards Act.

Bidders shall also comply with "HUD Section 3" requirements for the training and employment of lower income residents of the project area. HUD Section 3 requires that, if possible, contracts for work in connection with the project be awarded to small business concerns which are located in or owned in substantial part by persons residing in the area of the project.

The City of Parkersburg will afford maximum opportunity to Disadvantaged and Women-owned Business Enterprises who submit a show of interest in response to this invitation and will not discriminate against any interested firm or individual on the basis of race, creed, color, sex, age, disability or national origin in the contract award.

Copies of Plans and Specifications and Proposal Forms may be obtained from the Purchasing Department of the City of Parkersburg. **There will be no fee for specifications.**

THERE WILL BE A MANDATORY PR-BID MEETING ON FRIDAY JANUARY 22ND AT 10:30A.M., ON THE FOURTH FLOOR OF THE CITY BUILDING.

A certified check or bank draft payable to the City of Parkersburg, Wood County, or a Bid Bond executed by the Bidder and a Bidder and Surety Company approved by the City of Parkersburg in the amount equal to five percent (5%) of the Bid, shall be submitted with each Bid, to guarantee the Bidder's entrance into a Contract, if given the award. No Bid Bond shall be waived or returned because the Bidder failed to or cannot comply with any requirements as set forth in Plans, Specifications, or any applicable statutes of the United States, the state of West Virginia and/or all local ordinances.

No Bid may be withdrawn for a period of forty-five (45) days after the time of the opening of bids.

Any contractor submitting a Bid on this project hereby certifies, indicates and acknowledges that he has a license and meets all the qualifications required by the statutes of the State and subdivision in which the work is to be performed. **NO BID WILL BE ACCEPTED WITHOUT THE CONTRACTOR'S W.Va. LICENSE NUMBER BEING INCLUDED ON THE BID SUBMISSION.**
